Excerpt from ICTV Constitution
Members' proxies
Any Member may appoint a proxy to attend and vote at a general meeting on their behalf in accordance with the
Corporations Act. Unless otherwise instructed, the proxy may vote as he or she thinks fit. A proxy is not entitled to vote
on a show of hands. A proxy must be appointed in writing and the form must be signed by the Member. The Secretary must ensure the proxy
form is available on ICTV's website. The proxy form must be deposited at the registered office of ICTV at least forty-eight hours before the relevant general meeting.
If a Member is present at a meeting, the authority of their proxy is not suspended unless a motion is passed at the meeting to suspend the authority of the proxy while the Member is at the meeting.
